



Senator Risch Protects Second Amendment Rights

Americans' constitutional right to bear arms is part of the very fabric that makes our country so great, and it is part of our way of life in Idaho.

Senator Risch stands firmly against the Left's attempts to diminish your rights.

Senator Risch is protecting your Second Amendment Rights with common sense legislation. Senator Risch has:

- Authored, introduced, and garner support for the *ATF Transparency Act*, which would enhance review fairness, speed, and transparency for the Bureau of Alcohol, Tobacco, Firearms, and Explosives' (ATF) background check and application processes for National Firearms Act (NFA) items. The legislation would ensure law-abiding gun owners experience a fair and speedy application process when exercising their Second Amendment rights;
- Cosponsored the *Traveler's Gun Rights Act*, which would ensure individuals with multiple physical residences, active duty military personnel and military spouses, and full-time Recreational Vehicle (RV) travelers are able to bear arms. Individuals in these cases often face residency-related issues that prevent them from practicing their Second Amendment rights;
- Cosponsored the *Federal Firearms Licensee Protection Act*, which enhances penalties for criminals who steal firearms from federally licensed firearms and ammunition dealers;
- Cosponsored the *Hearing Protection Act*, which reclassifies suppressors to regulate them like a regular firearm. This would provide Idahoans easier access to this hearing protection;
- Cosponsored the *Constitutional Concealed Carry Reciprocity Act*, which would allow individuals with concealed carry privileges in their home state to exercise those rights in any other state that allows concealed carry, while still abiding by that state's laws;
- Cosponsored the *Firearm Industry Non-Discrimination (FIND) Act*, which prohibits the federal government from entering into contracts with entities that support anti-2nd amendment policies; and
- Cosponsored the *Fair Access to Banking Act*, which would prevent banks and financial services providers from discriminating against constitutionally protected industries and law-abiding businesses, such as firearms manufacturers.



Senator Risch is fighting the Biden administration at every turn as it attempts to restrict your constitutional rights. Senator Risch has:

- Cosponsored a resolution to ensure Congress has an opportunity to block President Biden's pistol brace ban from implementation. The ban would require pistol brace owners to surrender their brace or register their firearm. Failure to do so would result in felony charges and massive financial penalties;
- Cosponsored *the Pistol Brace Protection Act*, which stops the ATF pistol brace rule by exempting pistol braces from regulation under the NFA;
- Cosponsored legislation to fight President Biden's lead ammo tackle ban. *The Protecting Access for Hunters and Anglers Act* will ensure Idaho's sportsmen and women can continue to use lead ammo and tackle rather than expensive alternatives; and
- Cosponsored the *Stop Harassing Owners of Rifles Today (SHORT) Act*, which will remove the taxation, registration, and regulation requirements in the National Firearms Act. A federal gun registry has no place in America, yet this administration is forcing millions of law-abiding Americans to either register these commonly owned firearms or become felons.
